- The City of Ketchikan reserves the right to reject any or all bids and to withdraw from sale any of the items listed and to waive any formalities or irregularities in the interest of the City.

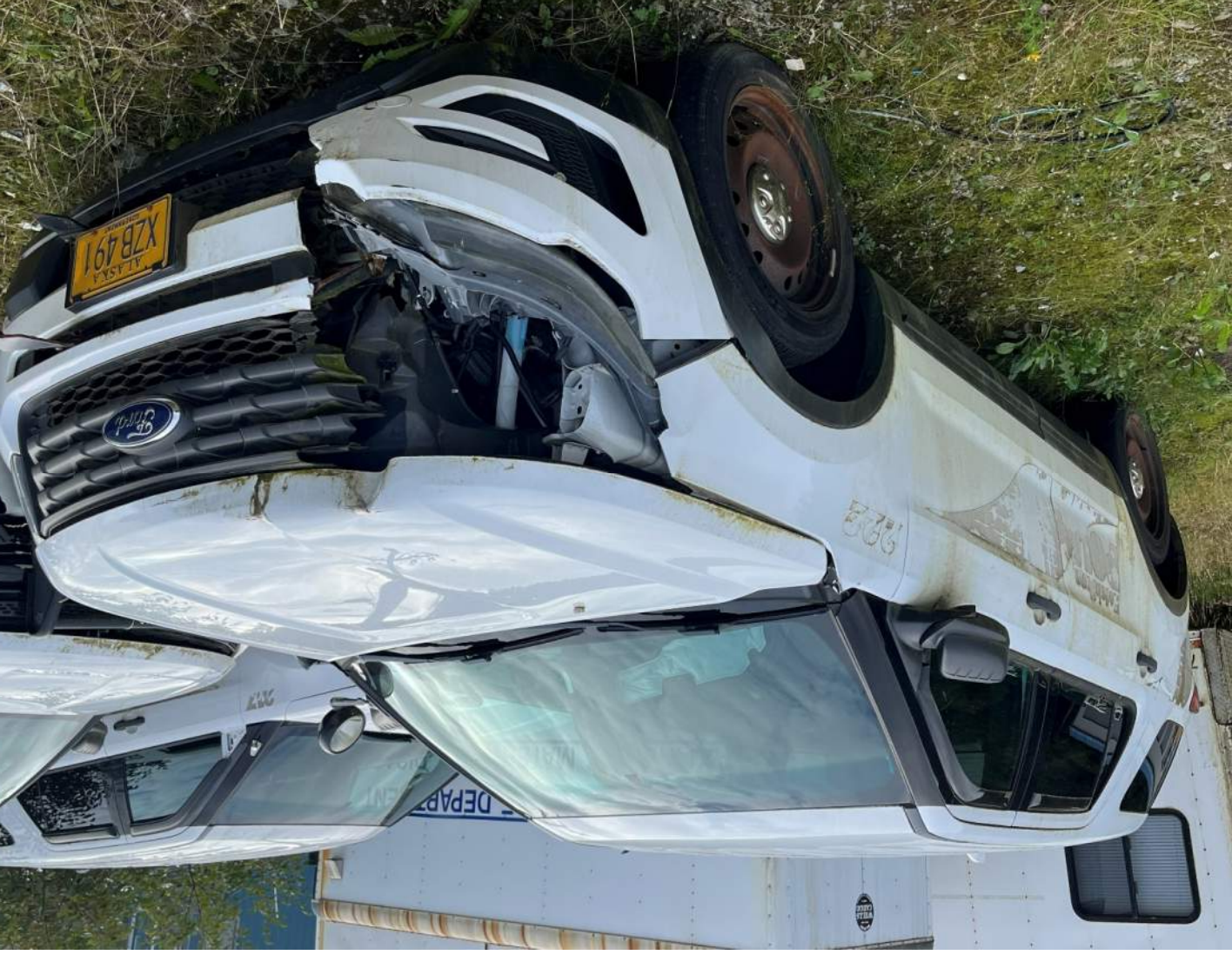
