On 05/06/19 at approximately 1948 hours, officers contacted William O'Connell, age 37, in the 600 block of Park Avenue. He was arrested on an outstanding warrant for Disorderly Conduct and Criminal Trespass in the 2<sup>nd</sup> Degree. He was transported to the state jail and was held on \$100 bail.
