DOCKING

Casey Moran aka City Float is our dedicated Open Moorage harbor. There is some dedicated Open Moorage at Bar Harbor North & South, Thomas Basin, Knudson Cove and Hole-In-The-Wall. Harbor maps are available upon request or on our website. You may come and go from an open moorage areas without requesting an assignment from the Harbormaster on a first come first served basis. All finger slips are leased to reserved stallholders. These stalls are assigned with Harbormaster permission only. Assignment does not guarantee the stall for the duration of your stay. You must be available to move the boat.

ELECTRICITY

All meters in Casey Moran are available for your use. In all harbors, except Casey Moran, meters available for your use are marked with a RED HP (Harbor Power) sticker near the meter's face. DO NOT use any other meters as they are privately held. If a vessel is plugged in to an HP meter, it will incur a daily charge based on the vessel length.

TENDERS/SKIFFS

Small tenders that can be stowed aboard may be allowed in the water beside the primary vessel at no cost. All others are subject to registration and moorage fees.

MOORAGE & ELECTRIC FEES

Please inquire at the office regarding rates, rules and check out time.

THEFT/DAMAGE/INJURY

The City of Ketchikan is not responsible or liable for any loss or damages to a vessel, or property on such vessel, or injury to persons within or upon Harbor facilities.
